Instructions on how to use the Adopt-a-Trail Application app

Note: The Adopt-A-Trail application is built to work on all devices, however due to a bug in the software the ability to submit an application for adopting a road, trail, or trailhead has been disabled for smartphone devices. For all other devices Tablet size and above, the application works as designed and these instructions apply to all device sizes, however the layout may have a slightly different look.





The List displays all available roads for adoption. At the top is a Search box where you can search by Street Name.

The Back to Main button will take you back to the main page.

Menu Navigation: When you select the icon, a menu will display that allows you to navigate to a different page, or open the instructions.

Completing the Hold Harmless Clause Section

Here, the Adopt-A-Trail Sponsor who is applying for the trail / trailhead, will review the Assumption of the Risk, Hold Harmless Clause, Waiver, and Responsibility requirements. After reviewing, the Sponsor will sign and date the form.

Hold Harmless Clause

ASSUMPTION OF THE RISK: As permittee, I hereby attest that I assume any and all risk associated with the Adopt-A-Trail for the applied for, and as described in my application, on behalf of myself and all of my employees, invitees, guests, agents, representatives, or subcontractors, their employees, agents, or representatives in connection with or incidental to the performance of this Adopt-A-Trail for the applied for and as described in this application, including all liability arising out of any services provided, or duty performed, by any party, as required by statute, law, purchase order, or otherwise.

HOLD HARMLESS CLAUSE: As permittee, I hereby attest that I shall indemnify, defend and save harmless, The Town of Oro Valley from any and all claims, demands, suits, actions, proceedings, loss, costs and damages of every kind and description, including attorney's fees and/or litigation expenses, which may be brought or made against or incurred by the Town on account of loss of or damage to, any property, or for injuries or death of any person, caused by, arising out of, or contributed to, in whole or in part, by reasons of any act, omission, professional error, fault, mistake, or my negligence, my employees, invitees, guests, agents, representatives, or subcontractors, their employees, agents, or representatives, in connection with or incidental to the performance of this Adopt-A-Trail for the applied for, and as described in my application, including all liability arising out of any services provided, or duty performed, by any party, as required by statute, law, purchase order, or otherwise. My obligation under this Section shall not extend to any liability caused by the sole negligence of the Town or its employees.

WAIVER: As permittee I hereby hereby waive the right to any claim for damages or injuries of any kind, accruing to me my employees, invitees, guests, agents, representatives, or subcontractors, their employees, agents, or representatives arising out of or as a result of any cleanup activity associated with my Adopt-A-Trail as applied for, and as described in my application, provided, however; no waiver shall apply to any claim which is caused by the sole negligence of the Town, or its offices and employees. RESPONSIBILITY: As permittee I hereby attest that it is my sole responsibility, and not that of the Town to obtain any indemnification, waivers, or insurance pertaining to any and all claims, demands, suits, actions, proceedings, loss, costs and damages of every kind and description, including attorney's fees and/or litigation expenses, which may be brought or made against or incurred by the me on account of loss of or damage to, any property, or for injuries or death of any person, caused by, arising out of, or contributed to, in whole or in part, by reasons of any act, omission, professional error, fault, mistake, caused by my negligence, or my employees, invitees, guests, agents, representatives, or subcontractors, their employees, agents, or representatives, in connection with or incidental to the performance of this Adopt-A-Trai for the applied for, and as described in my application.
