





Parcel History and Applicant Proposal









Existing Zoning Standards

R1-144 and Airport Environs Zone


- R1-144, not Rancho Vistoso PAD
 - While the property part of the Stone Canyon HOA, it is zoned R1-144.
- Building height
 - ▶ 18 feet
- Setbacks
 - > 50 feet from front of lot
 - 20 feet from side of lot
 - 50 feet from rear of lot
- Permitted Uses:
 - Single Family Residential
- ► Required Lot Minimum
 - ► 144,000 sq. ft.


